- Investment volume from € 7 million per object, preferred object size between € 15 million and € 40 million, no volume limitation

PLOTS OF LAND FOR NEW BUILDINGS

- Plots of land ready for residential development with a development plan, preliminary building application or planning permission
- Building volume between 4,000 sqm and 20,000 sqm GFA-R (above-ground)
- Pure residential use preferred – commercial share of up to 20% possible – share of social housing up to 30% possible
- Metropolitan regions, preferably cities with at least 500,000 inhabitants with positive, socio-demographic development and solid economic data
